**CLAUSE 1**

**COOPERATION**





**CLAUSE 2**  
**OBJECTIVES/SCOPE**

The goal is to foster collaboration, provide opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions. **Department of B.Com (CA), G.T.N Arts College (Autonomous), Dindigul-5 and Kaahgo Infotech** agrees:

1. To exchange information on research and educational programmes in the field of Computer Science.
2. To exchange information on teaching, learning material and other literature relevant to their educational and research program related to Computer Science.
3. To jointly organize short-term continuing education programmes on topics of mutual interest in the field of Computer Science and to invite each other's member of the team to participate therein.
4. To jointly organize seminars, conferences, FDPs, Guest Lectures and hands-on training on topics of Computer Science and to invite each other's team members to participate therein.

### **E. Coordination**

Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case-by-case basis, and will be consistent with the officially laid down IPR policies of the two institutions.

### **CLAUSE 4**

#### **TENURE, TERMINATION AND VALIDITY**

This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for One Academic Year from 2020- 2021, and may be continued thereafter suitable review and agreement. Either institution may terminate the MoU by giving written notice to the other institution six months in advance.

Once terminated, neither Department of B.Com(CA), G.T.N Arts College (Autonomous), Dindigul-5 nor Kaahgo Infotech will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, Department of B.Com.(CA), G.T.N Arts College (Autonomous), Dindigul-5 and Kaahgo Infotech will ensure that all activities in progress are allowed to complete successfully.

## **B. Student Exchange**

**Department of B.Com.(CA), G.T.N Arts College (Autonomous), Dindigul-5 and Kaahgo Infotech** agree that Department of B.Com.(CA) student exchange will be only for the sole purpose of educational research purposes like internships, projects, assignments, conferences and workshops and will be guided by principles listed below.

A home institution refers to the institution where a student is a full-time student or part time attached to the same, and from where he/she is expected to gain some knowledge certificates or degrees. A host institution refers to an institution that receives a student for a brief period of time to undertake a predetermined programme study or research/education programme.

1. Exchange students will be selected by mutual agreement between the home institution and the host institution.
2. His/her program of study at the host institution will be determined by mutual consultation between his/her academic adviser at the home institution and his/her "interim" academic advisor identified by the host institution.
3. The host institution will evaluate an exchange student's performance in each course or module; award a letter of appreciation/completion.
4. If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.
5. The exchange students will be liable to pay any type of fees for if any, for that particular program.

## **C. Exchange of Scientific and Technical Material**

**Department of B.Com (CA), G.T.N Arts College (Autonomous), Dindigul-5 and Kaahgo Infotech** will exchange information on research and educational programmes and teaching/learning material related to Computer Science and other literature relevant to their educational and research programmes. Further, **Department of B.Com.(CA), G.T.N Arts College (Autonomous), Dindigul-5 and Kaahgo Infotech** agree to explore ways to share teaching/learning material, and other relevant literature, while respecting each other's intellectual property and other rights.

## **D. Joint Conferences, Workshops, FDPs, Guest Lectures, and Short-term Courses**


## CLAUSE 6






