Memorandum of Understanding

This **Memorandum of Understanding** (hereinafter called as the 'MoU') is entered into on this the 17th March Two Thousand and Twenty (17.03.2021), by and between Department of tamil (SSP), G.T.N. Arts College (Autonomous), Dindigul – 624005.

Arts College (Autonomous), Dindigul** (hereinafter referred to as 'First Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

Dindigul Ilakkiya kalam, Dindigul, The Second Party, and represented here by **Mr. S. Ramamoorthy, Secretary**, Dindigul Ilakkiya kalam, Dindigul, (hereinafter referred to as 'Second Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

Purpose

Both the parties recognize the benefits to be derived from mutual collaboration, cooperation and interaction towards enhancement and development of Tamil Language. Hence, the Parties desire to work together with the following objectives.

1. Forms of Co-operation

Within such fields as are mutually acceptable for the Parties, the following forms of co-operation, amongst others, may be pursued hereunder:

- Exchange of students
- Joint teaching activities
- Joint research activities
- Visits by, and exchange of, scholars, teachers and other staff.

2. Specific Co-operation Projects

Specific co-operation projects, for instance within such fields as described in section 2 above, must be negotiated separately (if required) between the Parties and are in each specific case to be established in separate written agreements, stating the respective rights and obligations of the Parties. In case of any ambiguity or conflict of terms between the terms and conditions of this MoU and those of a separate agreement as mentioned above, the terms and conditions of such separate agreement shall prevail.

Forms of Co-operation:

1. Collaboratively, coordinating Book Fairs conducted by Dindugal Ilakkiya kalam. Knowledge transfer through different publications, Opportunities to read chosen literary pieces.
2. Interactions with critically acclaimed writers, authors and creators.
3. Literary understanding through evening programme routines like Thinkers & artistic forums.
4. Participative training through continuous debate.
5. Taking part in the journey of cultural unravels through archaeological study like keezhadi (an oldest civilization, happens to be of Tamil race)
6. Conceptualize, discuss and finalize topics on poetry, essay writing and speech contests conducted by Dindigul Ilakkiya kalam, participation as judges and amplify their views and ideologies.
7. Participating in reading camps organized by Dindigul Ilakkiya kalam and develop knowledge in literary criticism.
8. Participating in competitions on literary greats like Bharathi, Uu.Ve.Sa, Pudhumai Pithan, ect..
9. Acquisition of literary wisdom through fellowship among tamil teachers, professors and scholars.
10. Enriching the intellect through Organising, Conducting and participating in Workshops on Short story writing, Poetry writing and Essay writing.

3. Financial Arrangements

Both Parties understand that all financial arrangements between the Parties have to be further negotiated and mutually agreed, and will depend on the availability of funds. Both parties may seek financing of joint activities from internal and external sources available to them.

4. Liability

Except for loss or damages caused through gross negligence or intent, the Parties shall have no liability to each other hereunder.

5. Legal Relationship

This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the Parties. Nothing in this MoU shall create any legal relationship between the Parties.



6. **Commencement, Renewal, Termination**


